# CITIZENS' COMMISSION ON JAIL VIOLENCE TO PRESENT FINAL RECOMMENDATIONS TO BOARD OF SUPERVISORS

Presentation of Recommendations for Reform of Los Angeles County Jails

Los Angeles, CA – On Tuesday, October 9, 2012 at 9:30 a.m., the Chair, Vice Chair and Executive Director of the Citizens' Commission on Jail Violence (CCJV) will present the findings and recommendations from the Commission's final Report to the Los Angele County Board of Supervisors.

The Commission's final Report, released at the Commission's meeting last Friday, includes 63 recommendations supported by 77 findings. The recommendations and findings are the culmination of a 9 month investigatory process that involved interviews of over 150 witnesses and review of over 35,000 pages of documentary evidence. The Report focuses on six key areas: use of force, management and leadership, personnel, culture within the jails, discipline and independent oversight. Tuesday's presentation will enable the Commission to address questions from the Board of Supervisors and present the Report's clear roadmap for moving forward and addressing longstanding force issues in L.A.'s jails.
